## It is unlawful to operate an ATV/UTV...

...on a designated Snowmobile Trail from December 31, or the trail is groomed for Snow, until the Thursday before Memorial Day weekend.

...in any Rusk County
Parks and Campground;
except for the parking area
at Audie Lake Picnic Area
and the Josie Creek
Campground

...at any Rusk County
Boat Landing except from
November 16<sup>th</sup> to March
14<sup>th</sup>.

...posted areas authorized by the Rusk County Land and Forest Committee. It is illegal to operate an ATV/UTV in any navigable water or on the exposed bed of any navigable water. This includes most streams and rivers.

ATV/UTV operation is prohibited on any state lands unless on designated and signed ATV/UTV trails.

You are responsible to know who owns the land on which you are riding.

## ATV/UTV USE ON RUSK COUNTY FOREST LAND



Rusk County Forest land is closed to all motor vehicles from March 15 to the Thursday before Memorial Day.

Closing may be extended due to wet weather conditions. You are responsible to check before you ride.

All ATV/UTVs must be registered when operating on any public trails or lands.

It is illegal to operate an ATV/UTV on private property without the consent of the property owner.

## Bucks Lake ATV Loop Trail

This trail is located in the Towns of Wilson and Murry. There is an ATV Loading Unloading Parking Area and Day Use Area located near Bucks Lake (NW 1/4, Sec. 26, T36N, R9W)



This trail also has a connector trail to the Tuscobia State Trail.

2 Remote campsites are located next to the ATV/UTV Day Use Area.

## AREAS CLOSED TO ALL MOTORIZED VEHICLES

Cross-County Ski Trails (East Side) -That part of Section 4,5 and 6, T35N, R.8W, lying east of the Fire Lane Road, known and signed as the Rusk County Trails Association Trails.

Hunter Walking Trails and West Side Ski Trails- That part of Section 1, T.35N, R.9W and Section 6, T.35N, R.8W, lying west of Fire Lane Road and south of Perch Lake Road and east of Audie Lake Picnic/Campground.

Bucks Lake Emergency Spillway Area and Bucks Lake Dam Dike Area. – located in Section 26, T.36N, R.9W.

Perch Lake Nature Traillocated in Section 31, T.36N., R.8W and Section 36, T.36N, R.9W.

Audie/Perch Lake Electric Right-of-Way — located in Sections 1 and 11, T.35N, R.9W and Section 36, T.36N, R.9W Closed Areas To All Motorized Vehicles Continued

Ice Age Trail — it is unlawful to operate or permit the operation of any motorized vehicle on the Ice Age Trail at any time.

Blue Hills Felsenmeer State Natural Area — located in Section 31, T.35N, R.9W.

Josie Creek Rifle Range and Archery Walking Range – located in Section 14, T.35N, R.5W.
